The motion was put to a vote and the motion was carried
- *Council went over budget with a few additional adjustments. Budget fund line items were approved. Josh Sangl made a motion to approve the budget as presented. Logan Wilder and Tim Ray seconded the motion. The motion was put to a vote and the motion was carried.
- *Council also reviewed the underfunding of our 2024 DLGF Budget and Made a motion to approve the additional appropriations that will need to take place in the amount of \$62,155.30 for budget fund line Accounting/Consultants. This will help us get our records up to date for proper reporting in the future. Josh Sangl made a motion to approve the additional

appropriations in the amount of \$62,155.30 Logan Wilder and Tim Ray seconded the motion. The motion was put to a vote and the motion was carried.
